Notice For Fresh/Bye Election of Office bearers/Member (One post of Sr. Vice President, One post of Vice President and One Executive committee Member) of NFI Election-2021.

Notice is hereby given to all affiliated State Association of Netball Federation of India to conduct Fresh/Bye election of One Sr. Vice President, One Vice President, One Executive Committee member of the Netball Federation of India as per the following schedule and in accordance with the Constitution of the Netball Federation of India (copy of the said Constitution may be seen from the website of the NFI (www.netballindia.in) and National Sports Development Code and rules, regulations and model election guidelines evolved by the Ministry of Youth Affairs and Sports, Government of India(copy of the said guidelines may be seen from



the website of the Ministry of Youth Affairs and Sports, Government of India <a href="http://vas.nic">http://vas.nic</a>, <a href="mailto:in/sports/national-sports-development-code-india-2011">in/sports/national-sports-development-code-india-2011</a>).

2. (a) In pursuance of orders of Govt. Of India, Ministry of youth affairs and sports, Department Of sports, Vide dated 24<sup>th</sup> Feb 2021, the Ministry has ordered for the fresh Elections of the post of Sr. Vice President on account of vacancy arising of demitting of the post by Shri Hari Om Kaushik on 28 August 2020. The reason for demitting the office of the post of Sr. Vice President by Shri Hari Om Kaushik which, inter-alia, states that:-

"No person who has already held the office of the President or Secretary/Secretary General or both in a National Federation /Association consecutively for two terms or eight years shall be eligible to seek re-election to any of the said offices or Vice President or Treasurer till the expiry of a period of at least four from the date on which he last vacated his office".

- 2.(b) Bye Election of the seats of One Vice President and one Executive Member which becomes vacant by reason of resignation of Shri Deep Kumar Vice President on 17<sup>th</sup> November 2020 and Shri Vhim Khati Executive Member on 4<sup>th</sup> January 2021.
- 2.(c) The General House of NFI has unanimously decided to conduct fresh/Bye election of these posts immediately as per existing Acts/Laws/Regulations of NFI.
- 2.(d) The fresh/Bye elections are required to be held under the orders of Ministry of Youth Affairs & Sports (Government of India) vide dated 24<sup>th</sup> February 2021.
- 2 (e) The term of these posts will be for remaining period of the term of NFI i.e. upto 23th August 2024.
- 2.(f) The Executive Committee of NFI shall consists of 18 (eighteen) office bearers and 10(ten) Executive members elected by the general council which shall be as follows:-

i) President	1(one)
ii) Sr.Vice President	1 (one)
iii) Vice Presidents	7(seven)
iv) Hon. Secretary General	1 (one)
v) Hon. Treasurer	1 (one)
vi) Associate Secretaries	7(seven)
vii) Executive Members	10(ten)

3) Election shall be held at the Annual General Meeting (AGM) on 19<sup>th</sup> September,2021 strictly in accordance with the Constitution of the Netball

Federation of India and **National Sports** Development Code and rules. regulations and model election guidelines issued by the Ministry of Youth **Affairs** and Sports, Government of India.

- 4) Office Bearers (One Sr. Vice Presidents, One Vice President) and one member of Executive Committee of NFI shall be elected by secret ballot.
- 4(a) Each Affiliated Association, as per Article 5(4) of the Constitution, shall have two vote at the election of the office bearers and Executive Committee Member. For the purposes above, each affiliated Association shall be represented by two representative duly authorized jointly by the President and General Secretary of the affiliated Association.
- 4(b) Those who shall have right to vote is as follows:-
  - (i) Two representative from each affiliated unit
- He must be a member of the Association which he seeks to represent. Any such authorization which is not signed jointly by the President & Secretary of Association shall not be taken.

- 7. The nomination of a candidate for election as office bearers or a member of Executive Committee shall be proposed by one of the representatives of member states/Union Territories whose name is included in the Electoral College list in Form 1 and also subscribed by 1 (one) such representative as seconder.
- 8. Each candidate shall be entitled to be nominated by not more than 2 (two) nomination papers.
- 9. Each nomination paper shall be delivered personally to the Returning Officer in person OR through Online mode via Video conferencing as per the Schedule mentioned above. The facility for delivering nomination paper by the candidate himself/herself in person to the R.O shall be for those members who resides in Delhi/NCR and the members who resides outside Delhi/ NCR should deliver nomination papers through online via video conferencing. The members who resides outside Delhi/NCR and who wish to file nomination in person should also file nomination papers on fixed date and time to the R.O. Submission of Online nomination via Video Conferencing shall be available as a special case because of inter-state travel restrictions and Lockdown in some states/UTs due to COVID-19 pandemic. 10. No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder; and, if he so does, his/her signature on the nomination paper delivered second in point of time to the returning officer shall be
- deemed to be inoperative.
- 11. No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been delivered to returning officer.
- 12. At the scrutiny of nominations, each candidate or one of his/her authorised representative shall have the right to be present and raise any objection in relation to nominations of the candidate for the post for which he/she has filed his/her nomination. ML

- 13. On the day of scrutiny, the Returning Officer in his Office shall scrutinise each nomination paper, one by one, received by him in person or through online via Video Conferencing and determine its validity or otherwise.
- 14. At the scrutiny of nominations, each candidate or one of his/her authorised representative shall have the right to be present in person OR through online via Video Conferencing and raise any objection in relation to nomination of a candidate for the post for which he/she has filed his/her nomination. As soon as may be after the scrutiny of all nomination papers has been completed by him, the Returning Officer shall prepare a list of validly nominated candidates in **Form 4**. and post it on the website of NFI; Contesting Candidates can take a copy from the Returning Officer.
- 15. Each candidate whose nomination has been found valid on scrutiny, shall be entitled to withdraw his/her candidature in person or through Online via Video Conferencing From 1<sup>st</sup> September, 2021 (Wednesday) and 2<sup>nd</sup> September, 2021 (Thursday) between 2.00 p.m. and 5.00 p.m.
- 16. Notice of withdrawal of candidature shall be submitted in **Form 5**,in person or through Online via Video Conferencing either by the candidate himself/herself or by a person duly authorized by him/her in writing.
- 17. Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.
- 18. The Returning Officer shall accept the notice of withdrawal if he is satisfied as to the genuineness of the notice.
- 19. As soon as may be after the withdrawal of nominations, the Returning Officer shall prepare the final list of contesting candidates in **Form-6**, display a copy of the said list in conspicuous place in his office and websites of NFI and also furnish a copy of the same to each of the candidates/their authorised representatives, if they so demand.

- 20. The names of the contesting candidates in **Form 6** shall be arranged, for each post, in alphabetical order according to English alphabets.
- 21 Where the number of contesting candidates for any post, in **Form 6** is equal to the number of posts to be filled, all such contesting candidates shall be deemed to be duly elected unopposed to those posts, and it shall not be necessary to take a poll for election to such post.
- 22. Where the number of contesting candidates for any post, in **Form 6** is more than the number of posts to be filled, a poll shall be taken by secret ballot for those posts remaining unfilled.
- 23. The ballot papers for these posts remaining unfilled shall be in Form 7 to Form 9 to be made individually for each post.
- 24. The names of contesting candidates on the ballot papers shall appear in the same order as in **Form 6**.
- 25. Each contesting candidate can nominate one person, (If he/ she so desires), only from amongst the list of Authorized Representatives (Form 1), to be present at the Poll (Polling station).
- 26. At the poll, each authorised representative of Affiliated Association and whose name is included in the Electoral College list in **Form 1**, shall be entitled to
  - (i) cast one vote for each of the posts remaining unfilled, where only one such seat is to be filled.
- 27. In case any voter casts his/her vote for more than the candidate, or candidates to be elected from any post, his/her vote for that post shall be invalid.
- 28. Each voter shall be required, before he is supplied with a Ballot paper, to give his/her signature on the authenticated copy of the Electoral College list in **Form 1** used by the Returning Officer for taking the poll.
- 29. The voter shall record his/her vote on the ballot paper in secrecy in a voting compartment specially provided for the purpose at the polling station.

- 30. The voter shall record his/her vote on the ballot paper by placing a tick mark  $(\sqrt{})$  against the name of the candidate of his/her choice, and any other mark, like (x) etc. or word, placed on the ballot paper by him/her shall render the ballot paper liable to rejection.
- 31. The tick mark ( $\sqrt{}$ ) to indicate the vote shall be placed by the voter only by means of article specifically provided for the purpose by the Returning Officer, and a ballot paper marked otherwise by means of any pen, ball point pen, etc. by the voter shall render the ballot paper liable to rejection.
- 32. The ballot paper marked by a voter shall be deposited by him/her in a ballot box specially prepared and sealed by the Returning Officer and placed at such a conspicuous place in the polling station that it shall be constantly visible to all present in the polling station.
- 33. The Returning Officer shall close the poll at the appointed hour; however, all those voters who are present at the polling station at the appointed closing hour shall be entitled to vote even if the poll proceedings have to be continued for some more time.
- 34. After all the voters, referred to above, have voted, the Returning Officer shall close the ballot box and shall not permit thereafter any person to vote.
- 35. The Returning Officer shall take up the counting of votes as soon as may be after the polling is closed.
- 36. Each contesting candidate can nominate one authorised representative and he/she shall be entitled to be present at the place of counting of votes.
- 37. The Returning Officer shall take up the counting of votes, post-wise.
- 38. Each ballot paper on which a vote has been recorded, as mentioned above, shall be treated as one vote for the candidate for whom it has been validly marked; and if any ballot paper has been marked in violation of any of the aforesaid provisions shall be rejected by the Returning Officer.

39. The votes validly cast for each of the contesting candidates shall be counted post-wise, and recorded in the descending order of the votes so cast for each candidate in **Form 10**.

40. The Returning Officer shall thereafter ascertain the result of counting and the candidates who have secured the maximum no. of votes in the said descending order, post-wise, equal to the no. of seats to be filled for each post, shall be deemed to have been duly elected to those posts.

41. The names of contesting candidates who shall be deemed to have been elected at the election, as per mentioned above, shall be declared as having been duly elected to their respective posts, by the Returning Officer at the General Meeting (GM) in the **Form 11**.

42. If any person/affiliated association have any complaint, regarding this election, may contact to the Returning Officer and give in writing in the name of Returning Officer OR can send it through email of the Returning Officer (nfielection2021@gmail.com).
